## Foundation Exceeds \$500,000 Goal for Children's Center

Thank you for caring about our kids! The Chilton Medical Center Foundation is pleased to report that the Major Gift Initiative for the new Children's Center at Chilton has exceeded its \$500,000 goal. The oneyear fund drive was launched in January 2015 to support this pivotal \$4 million project, which is set to transform the hospital's delivery of pediatric services.

"We're astounded by the outpouring of support from our loyal community of donors," stated Amy Hershman, Foundation Trustee and Chair of the Major Gift Initiative. "Our success would not have been possible without the heart-felt generosity of area residents, along with charitable donations from foundations, corporations, hospital employees and other benefactors."

The Children's Center at Chilton will pioneer a new approach to pediatric care by combining the hospital's Pediatric Emergency Department and Pediatric Inpatient Unit in one state-of-the-art facility. Among the first of its kind in New Jersey, the unique, child-friendly space will provide

Phillip Devadan, MD, serves as Medical Director of Chilton's Pediatric Emergency Department as well as the clinical champion for its new Children's Center, which is scheduled to open in 2016. Among peers and colleagues, he's regarded as a highly skilled, board certified pediatrician specializing in emergency medicine. Out in the community, however, he's simply Dr. Devadan – a familiar, trusted physician who loves caring for kids (and saving lives, too).

## **Q.** After studying abroad and training in New York City, why did you establish roots at a community hospital? Why Chilton?

**A.** After my fellowship at Mt. Sinai, I was planning to head back home [to Ohio] when I met a few doctors from Chilton. They asked me to create a Pediatric Emergency Department for this growing community, and it was the best thing I ever did. We started small – open 4 p.m. to midnight, weeknights only – but quickly expanded to accommodate the needs of area families. Thirteen years later, Chilton operates an around-the-clock, state-of-the-art pediatric emergency room that is staffed and equipped to handle everything from fractures to trauma.

#### **Q.** How has Chilton's Pediatric Emergency Department changed and improved over the years?

A. When we opened our doors, we treated about 5,000 kids annually. Since then our volume has tripled. Today, Chilton's Pediatric Emergency Department treats more than 15,000 children, from newborns all the way up to kids under the age of 18 – and each one is seen by a pediatric emergency doctor within 20 minutes of arrival. Our capacity and capabilities have increased with the community's population, while the quality of care has remained consistently high. In fact, according to industry benchmarks, Chilton's Pediatric Emergency Department ranks in the 99th percentile of hospitals nationwide for patient satisfaction.

#### **Q.** Tell us about the new Children's Center. How will it transform the delivery of care for pediatric patients at Chilton?

A. Children are not little adults, so it is important that we consider their specialized needs and isolate them from other patients. Our new Children's Center will be among the first of its kind in northern New Jersey, combining the hospital's pediatric services in a single, child-friendly space. Chilton plans to build a 4,500 square foot facility to house our Pediatric Emergency Department and Inpatient Pediatric Unit, which means that all children will be treated by the same doctors, nurses and staff. This hybrid model promotes continuity of care, along with healing and recovery. It's the wave of the future... and shows that Chilton understands that pediatrics is a true subspecialty.

#### **Q.** Will the Children's Center offer any additional pediatric services?

**A.** Yes. Patients soon will have access to Child Life Specialists who are focused on creating a better hospital experience for children and their families. As experts in child development and an integral part of our medical team, they'll offer emotional and social support, therapeutic activities, coping strategies and education. Recently, we also introduced a Creative Arts Therapy Program to help kids manage their stress through music, art and self-expression. Both of these services are terrific additions to Chilton's comprehensive continuum of pediatric care.

#### **Q.** What do you find most gratifying about your work at Chilton?

**A.** The kids! I love taking care of children and watching them grow. My patients recognize me in the grocery store, and often know me by name. They visit me in the hospital, not just when they're sick but also when they're well. Some have even gone on to pursue their own health care careers. Three or four have graduated from medical school, others are physician assistants and at least one of my former patients is interested in nursing. It is gratifying to think about how many kids I've helped...and to know that I've had a meaningful impact on their lives.

Home, Sweet Home Pompton Lakes Resident Gives Generously to Chilton



Sinikka Sarro was born and raised in the Republic of Finland, where she enjoyed a wonderful childhood. But aspirations fueled her desire to travel. In the late 1960s, as a young woman, Sarro visited the United States to master the English language, advance her education and see the world.

She began her journey in search of opportunity, but ultimately found a home.

Within a few years, the couple settled in Pompton Lakes, New Jersey – and Sarro has remained there ever since. At 70 years of age, she's still enamored by the vibrant, picturesque suburb, as well as its community hospital.

The Breast Center at Chilton Medical Center

The longtime Passaic County resident has always valued Chilton Medical Center, frequenting the hospital for surgical procedures, health screenings and other medical needs. But her appreciation grew exponentially in 2013, when a routine mammogram at Chilton's Breast Center revealed a tiny abnormality. In fact, she credits the hospital's state-ofthe-art 3D mammography, as well as its skilled physicians and staff, with detecting her early-stage breast cancer and ultimately saving her life. "The mass was so small that I might not have been diagnosed so guickly if not for that technology," she said.

Following surgical treatment, Sarro relied on Chilton for seven weeks of radiation therapy. "Everyone was wonderful," she added, emphasizing her gratitude for Chilton's leading edge services along with its "homey feel" and compassionate, personalized care.

Over the last eight years, Sarro has donated generously to Chilton Medical Center, including gifts in honor of her caregivers and a recent major gift to support important hospital initiatives. Additionally, she is a member of the Foundation's Legacy Circle, which recognizes individuals who support the hospital through estate planning. Sarro has designated Chilton in her will, along with other charities that are close to her heart.

"I'm fortunate to be in a healthy financial situation and enjoy sharing it," she stated. "Chilton has grown and changed so much over the years; I feel proud to contribute. I want to ensure that we have a good hospital in my neighborhood... and that it's there forever."

## **All in the Family**

Chilton Pharmacist Memorialized with Honorary Gift

Family often brings the greatest joys in life. That may be why the late Walter A. Markley II is keenly remembered for his radiant, charismatic smile. He probably considered himself the luckiest man in the world, because this longtime pharmacist and Morris County resident didn't have just one family to cherish... he had two.

In addition to his beloved wife, Diane, his three sons and five grandchildren, Walter found a second family at Chilton Medical Center, where he worked the Pharmacy's evening shift for 30 years. By all accounts, he was deeply devoted to the hospital, his patients and colleagues – often regarded as a friend and mentor. So it seems only fitting that the Markley family chose to honor Walter's generous heart with a generous donation to the new Children's Center at Chilton.

"My father's death was a shock to all of us, but our family takes great comfort in supporting the charity he cared about most," asserted his eldest son, Brian Markley. "He loved Chilton and he loved kids, so I'm certain he would be very proud."

Raised in Dumont, New Jersey, Walter Markley discovered his passion for health care at an early age. In fact, his professional pursuits emerged as a teenager, when he was hired by a local pharmacy to deliver medication to area residents. According to one of his co-workers, the high school job inspired Walter's "calling," leading him to Rutgers University where he earned his registered pharmacist certification in 1974.

After beginning his career in Newark, Walter secured a part-time position at Chilton – and worked two jobs until the perfect opportunity came along in 1983. That's when he stepped into a full-time role at Chilton, operating the Pharmacy at night so he could be with his children during the day. "He was a great dad," said Brian. "He worked a lot, but moved our family to Pompton Plains so he could spend his dinner hour at home."

At Chilton, Walter quickly earned the respect and admiration of his peers, who describe him as diligent,

meticulous and kind. "He knew everyone at the hospital, from the surgeons to the custodians," noted Brian. At one



time, people referred to him as the "Mayor of Chilton," because Walter established relationships with all of his colleagues and many patients, too. "He was a guy who really enjoyed meeting people, getting to know them and caring about them," his son added. "That's what made him an exceptional pharmacist, and part of the fabric of the institution."

As a testament to his work ethic and accomplishments, Walter was named Chilton Medical Center's very first "Employee of the Year" in 2002. His children would beam with pride when they visited their father at work, and saw Walter's picture hanging on the wall. According to his son, Dr. Jonathan Markley, the young men viewed him as a tremendous role model who led by example – and taught them to make a difference in the world. One of Walter's sons became an attorney and two practice medicine, proudly perpetuating their father's legacy. In fact, you can often find Dr. Daniel Markley in Chilton's Critical Care Unit, healing patients and compassionately helping those in need. Just like his Dad.

While his life on earth has passed, Walter Markley will have an everlasting presence at Chilton Medical Center – through the stories and memories shared by his co-workers, a new generation of Markley physicians and the countless lives he touched over the course of his 66 years.

In recognition of the Markleys' philanthropic generosity and Walter's inspiring service, the Chilton Pharmacy has been named in his honor.

"Walter would have loved it," stated Chilton pharmacist Sushil Jain. "This was Walter's second home, and he was part of our family."

## **Heart of Gold**



The late Sonia Neill embraced life with a spirit of adventure – and a heart of gold. She and her husband, Harold, trekked across the United States in a camper, explored the tropical beaches of Tahiti and toured their way through Europe. Yet, according to her loved ones, the place that Sonia treasured most was her "country" home in Pompton Plains, where she resided for 30 years. As it turns out, she traveled the world but never lost sight of her own community and her community hospital.

According to her wishes, Chilton Medical Center received a \$2.2 million bequest to benefit enhancements for the Chilton Collins Pavilion, which houses the medical center's Cancer Center and Breast Center. The gift, both extraordinary and unexpected, was donated quietly but speaks volumes about this thoughtful, compassionate visionary who valued the importance of community health care.

As the only daughter of German immigrants, Sonia spent much of her childhood in Guttenberg, New Jersey, where her parents owned and operated an embroidery factory. Perhaps it was those roots that instilled her strong values and commitment to family. For it was there, in a cozy, neighborhood cafe, that Sonia established a lifetime friendship with the proprietor and her youngest son, Brian Montmore. Sonia and her husband did not have children of their own, but shared their love with Brian, whom they treated as an "adopted son."

In the early 1960's, Sonia and Harold Neill moved to Pompton Plains, where they bought a charming little house with a white picket fence. They lived modestly, but generously – welcoming Brian to visit often and spend summers in their lakeside community. Brian fondly recalls boating along the Pequannock, flying kites attached to fishing poles and shopping around town with "Aunt Sonny." Early on, Brian recognized Sonia's charitable nature through her desire to help others, whether she was driving an elderly neighbor to a doctor's appointment or finding a home for a stray pet.

"Aunt Sonny was extremely kind," he asserted. "She cared about people, especially children, and also loved animals. She believed in volunteering and giving back to the community."

Over the years, Sonia also developed a strong connection to Chilton Medical Center. According to Brian, it was her hospital of choice when she needed surgery, emergency care or other health services. Somewhere along the way, Chilton secured a special place in Sonia's heart.

Even after she and Harold retired to Florida, Sonia asked about her community hospital and her house by the lake. "She liked to hear all the hospital news and was excited to learn that my grandsons were born there," noted Brian. "She probably spent her happiest days in Pompton Plains."

In 2013, Sonia Neill passed away. It wasn't until then that Chilton Medical Center learned of her bequest to the hospital's Collins Pavilion – and the magnitude of her philanthropy. Most of Sonia's estate was left to her favorite charities. Unfortunately, the Chilton Medical Center Foundation did not have the opportunity to thank Sonia personally for her incredible gift. However, as a gesture of gratitude, the Foundation invited her dear friends and loved ones – the Montmore family – to the hospital in July for a celebration to recognize Sonia's benevolence.

"Chilton Medical Center Foundation is deeply grateful to Sonia Neill for considering the hospital in her estate planning and recognizing Chilton's vital role in the community," noted Joan Beloff, Chief Development Officer. "Her foresight and selfless generosity will support many programs and services that benefit patients in our Cancer Center and Breast Center, and will impact the health of area residents for generations to come."

## World Renowned Physicians Join Cancer Center

Chilton's Cancer Center has once again raised the bar in cancer care, welcoming internationally recognized radiation oncologists to its highly skilled medical team. James R. Wong, MD, Mona Karim, MD, Yana Pavel Goldberg, MD and Todd Carpenter, MD are trained in all subspecialties related to cancer and are leaders in their field. In fact, Dr. Wong is acclaimed for developing imageguided radiation therapy (IGRT) – one of the most significant breakthroughs for precisely targeting and treating tumors.

The group's expertise is now available to patients at Chilton, along with the latest diagnostic and cancer-fighting innovations, including IGRT, 3-D treatment planning systems and simulators, Intensity Modulated Radiotherapy (IMRT), and a state-of-the-art linear accelerator with "RapidArc Rotational Radiation Therapy." The radiation oncologists work collaboratively with Chilton physicians, oncology-trained nurses and other specialists to develop personalized treatment plans for each patient while providing our community with a full continuum of centralized, cutting edge cancer services. Furthermore, Chilton is affiliated with Atlantic Health System's Carol G. Simon Cancer Center, based at Overlook and Morristown Medical Centers, which offers seamless access to additional experts, clinical trials and advanced care for patients with rare or complex cancers.



## **Healing with Nature**

Chilton's Total Joint Center recently completed its new Healing Garden, to be unveiled in 2016, which was generously funded by Mimi and Eddie Feliciano of Kinnelon and other community donors. Reflecting the hospital's holistic approach to care, this beautiful outdoor oasis offers a serene, peaceful environment for orthopedic patients to advance their recovery, relax and socialize with family and friends.

The unique space embraces the healing effects of nature, as studies confirm that outdoor gardens can have a positive impact on one's physiological, mental and emotional well-being. The beautifully designed landscapes are proven to alleviate stress and pain while boosting the immune system, reducing post-operative complications

and shortening hospital stays. Chilton's Healing Garden will officially open in 2016, providing the perfect complement to the Total Joint Center's comprehensive, award-winning patient care.

## Chilton Pioneers New Therapy for Peripheral Artery Disease

Chilton Medical Center is among the first hospitals in New Jersey to offer a promising new treatment for peripheral artery disease (PAD), a dangerous condition that occurs when fatty deposits accumulate inside the arteries and restrict blood flow. While many cases are successfully managed with exercise, lifestyle modification and medication, others require interventional therapy to clear the blockage mechanically.

Chilton physicians recently pioneered the latest breakthrough in PAD care, drug-coated balloons, which open constricted arteries and deliver medication to the artery walls. Early results



suggest that this technique is highly effective, reducing the need for repeat procedures while relieving symptoms and lowering the patient's risk for amputation, heart attack, stroke and other life-threatening complications. According to interventional cardiologist Lawrence Blitz, MD, "Chilton has one more option to help individuals control their disease and lead a healthier life."

## Heart Success Program Improves Cardiac Care

Chilton Medical Center recently introduced a "Heart Success" program to provide specialized care for patients with advanced heart failure, cardiomyopathies and pulmonary hypertension. Participants are thoroughly assessed by a team of clinicians, including registered nurses, nurse practitioners, dieticians and pharmacists, who develop a customized treatment plan for patients and their families. A new component of Chilton's network of heart services, the "Heart Success" program incorporates intensive education on self-care and telemanagement, while providing access to cutting edge research, diagnostic testing, interventional therapy, cardiac rehabilitation, integrative medicine, and transplant evaluation. The goal is to help heart patients prevent hospitalizations while improving their health and well-being.

## **Chilton Introduces Specialty Suites at Cedar Crest**

Last September, Cedar Crest retirement village celebrated the grand opening of Chilton Medical Center Specialty Care Suite, which is conveniently located on its Pompton Plains campus. Introducing a groundbreaking approach to health care delivery, the new, beautifully appointed suites bring specialty medical services right to the residents' doorstep – allowing them to visit physicians "at home" rather than traveling to their offices. This is a tremendous

benefit to many Cedar Crest residents burdened by mobility issues, lack of transportation or other obstacles that may cause unnecessary stress or missed medical appointments.

In partnership with the senior living community, Chilton Medical Center Specialty Care Suite is staffed by experienced Chilton physicians representing the following specialties: cardiology, vascular medicine, medical oncology, urogynecology, neurology, orthopedics, gastroenterology and endocrinology.

The Pediatric Clinic is a full-service health clinic that provides health care for the community, regardless of insurance status or the ability to pay. Located at 242 West Parkway in the Atlantic Rehabilitation building about a mile from the main hospital, the Clinic offers high quality, primary pediatric and medical care to patients while producing measurable, long-term improvements in healthy behaviors, healthy outcomes and better quality of life. Last year, the Clinic provided care for over 2,500 patients of culturally diverse backgrounds from Chilton's service area of Morris, Essex, Sussex, Passaic, and Bergen counties.

## **Music Heals**

The Tones, a Healing Arts music therapy group for children within the Autism spectrum disorders, enjoyed its second session at Chilton Medical Center this past summer. Made possible with a gift from local residents and longtime Chilton donors Angelo and Lonny Badalamenti, this program offered children ages 6-10 an opportunity for communication and socialization through music improvisation and movement. Led by a board certified music therapist, children and caregivers together create music with instruments, sing songs, and move with parachutes and scarves.

The goal of the study is to find a reliable ovarian cancer screening test for women which will contribute to early detection and improve survival rates.

## Women's Vision for Health Care Council

Research shows that nurses should be educated and certified in gerontological nursing care, to provide the best possible care to older patients. However, less than one percent of our nurses are currently certified in gerontology nursing. Over the next several years, Chilton's goal is to certify 25 nurses in this discipline. "The funds will allow us to implement this certification program and eventually deliver a "Geriatric Resource Nurse" (GRN) model of care here at Chilton," says Carnette Smith, RN, MSN Clinical Educator, NICHE Coordinator.

## Driven to Give

On Monday, October 26, Lincoln of Wayne held an event to benefit the Children's Center Major Gift Initiative at Chilton. 
